The Regatta will be held on January 13, 14, & 15, 2012. The first race will be at 10:00 AM Local time on Friday, January 13, 2012. The Regatta will be postponed if the Northwest Ice Yachting Association Regatta is held on these dates.

Possible locations, in order of preference, are:  
Menominee, Green Lake, Madison, Detroit,  
Gull Lake, Lake Geneva, East Division, Pewaukee, Burlington Bay,

The races will be held for A, B, C Division Skeeters, Renegades and Nites.

The Entry Fee is \$15.00 per yacht.

Awards will be given according to Part II Section 3 of The International Skeeter Association Constitution, By-Laws and Racing Rules

Registration will be at Regatta Headquarters from 8:30 A.M. to 9:30 A.M. local time on Friday, January 13, 2012.
