Menekaune Musings

To my fellow Renegade iceboaters, officers and committee members,

As stated by our class designer and founder Elmer Millenbach, "If it does not look like a Renegade, it is not a Renegade." Those of you that know me know that I have a great passion for sailing our one-design class of iceboat, the Renegade. The intention of the one-design concept is to put all of us on the same playing field where the result of the races lies in the skills of the iceboater and conditions of the race day.

As I was looking across the ice at the end of our last regatta, I noticed from a distance that the runners on a boat did not look like the renegade runners. The profile looked more like the Sarn's bullnose runner, which provided this runner with longer running edge than the ones specified in our published technical guide.

As you may know a longer running edge has been shown through race results to provide faster times in certain conditions when using these runners in other classes. The advantage provided here is the result of changes in the design of the boat and not the skill of the iceboater. Our organization was based on a one design class of ice boat that levels the playing field and puts the skills of the sailor as the deciding factor in success or failure of their performance.

With the appearance of this new runner, I am also concerned about the longevity of our class. Not only maintaining our fleet strength, but also new sailors who will venture into our passionate pass time. I believe that the cost in time and money of these new runners could not only result in the loss of our current members but discourage a new generation of racers from joining, something we do not need.

My intent here is to protect the integrity of the one design Renegade. I ask that at our next annual meeting, as an agenda action item, our membership reaffirm our commitment to the one design concept of the Renegade according to our By-Laws, Millenbach's design and the Renegade plan guidance document as revised and amended.

2019 Notice of Race

The IRIYA is frequently held in conjunction with the ISA regatta. Once again, it is possible the IRIYA regatta will be held independently of the ISA regatta.

All races will be sailed under the rules of the National Iceboat Authority and those of the International Renegade Ice Yacht Association.

The regatta will be scheduled on January 4, 5 and 6, 2019. The first race will be held at 10:00 AM (local time) on Friday, January 4, 2019. In the event the IRIYA regatta is postponed, the IRIYA regatta will not be scheduled on the same weekend as the Northwest Ice Yacht Association (NIYA) regatta. The NIYA regatta will take precedence.

Awards shall be given to the yachts placing first through fifth.

Entry fee is \$15.00 per yacht payable upon registration.

Registration will be at regatta headquarters from 8:30 AM to 9:30 AM (local time) on Friday, January 4, 2019

If the IRIYA Championship regatta is sailed in conjunction with the ISA, the IRIYA will follow the same race format as the ISA. If the IRIYA regatta is held separately from the ISA regatta, there will be **nine** (9) races scheduled and **three** (3) races are necessary to complete the regatta.

Skippers may obtain sailing instructions at the time of registration.

For confirmation of the regatta dates, the primary source of information will be the IRIYA web site (www.iceboat.org/renegade.html) beginning at 6:00 PM CST on December 30, 2018, or 6:00 PM CST on the Sunday before the regatta. For final confirmation go to website after 12:00 PM CST on January 2, 2019, or the Wednesday before the regatta. If computer access is unavailable, the secondary source of information will be the Renegade Hotline number (608-520-0006) beginning at 6:00 PM CST on December 30, 2017. Information as to the site, headquarters, and accommodations will be available at 1:00 PM CST on January 2, or the Wednesday before the regatta. Members of the Race Committee can also provide regatta information. The 2019 Race Committee will be:
